UPDATE FURTHER TO PRIME MINISTER'S ANNOUNCEMENT 28TH MAY

On the 28th May the Government gave all Dental Practices permission to recommence seeing patients from 8th June.

As we never completely closed we expect to do this and be ready for the 8th June. It will not be possible to be back to business as usual immediately as extra precautions will be in place.

WHO WILL BE SEEN FIRST?

Initially we will be dealing with urgent cases that have built up and continuing to see all our emergencies and then treatments that have been started will be looked at. We ask everyone to contact us by phone first. Initially everyone will have a telephone consultation with a dentist before appointments are made.

Please can patients all phone on the day of their arranged appointment to confirm they and their household are clear of Covid-19 symptoms.

When you attend for an appointment we request you come without bags and coats, and wherever possible please use the toilet beforehand. This all helps to help reduce chance of the virus being spread.

Whilst we are dealing with this backlog, we will not be doing routine examinations. Please bear with us at this time.

All our staff will be wearing extra protection so we may look a bit strange but we are still the same underneath the masks.

Thank you for your patience. We look forward to seeing you all again soon.
